Reference is invited to HQrs office letter cited at reference (copy enclosed) wherein it was directed to make action plan for provision of solar panels in the office/residential complex under the administrative control of PCDA/CDA.

2. In this connection, it is once again reiterated that provision of solar panels of appropriate capacity depending on availability of space and feasibility in the office/residential complex under the administrative control of respective PCDA/CDA, be made and work sanctioned by PCDA/CDA if the same falls under the delegated power of PCDA/CDA. The requirement of funds may be projected to HQrs office after sanction and completion of contractual formalities for consideration of release of funds at this end.
