



SUBJECT: Nomination for National Awards for the Empowerment of Persons with Disabilities, 2017.

Sir/ Madam,

I am directed to say that this Ministry has been implementing the Scheme of National Awards for the Empowerment of Persons with Disabilities. The awards are given in the following categories:-

- (i) Best Employee/Self-employed with disabilities;
- (ii) Best Employer and Placement Officer or Agency;
- (iii) Best Individual and Institution working for the cause of persons with disabilities;
- (iv) Role Model;
- (v) Best Applied Research/Innovation or Product Development aimed at improving the life of persons with disabilities;
- (vi) Outstanding Work in the Creation of Barrier-free Environment for the persons with disabilities;
- (vii) Best District in providing rehabilitation service;
- (viii) Best State Channelizing Agency of the National Handicapped Finance and Development Corporation;
- (ix) Outstanding Creative Adult persons with disabilities;
- (x) Best Creative Child with disabilities;
- (xi) Best Braille Press;
- (xii) Best Accessible Website;
- (xiii) Best State in promoting empowerment of persons with disabilities;
- (xiv) Best Sports person with disability.

2. It has been decided that this year also the National Awards for the Empowerment of Persons with Disabilities shall be conferred on the International Day of Disabled Persons i.e. on 03rd December, 2017.

3. It is requested that wide publicity may be given to the National Award Scheme, 2017. It is further requested that the nominations for the awards, complete in all respects, may be forwarded so as to reach **Shri O.P. Dogra, Director, Department of Empowerment Persons with Disabilities, Ministry of Social Justice and Empowerment, B-II Wing, 5th Floor, Pt. Deendayal Antyodaya Bhawan, New Delhi latest by 15th August, 2017.** The application and the envelope both carrying it should be superscribed with "**Nomination for National Award for the Empowerment of Persons with Disabilities, 2017** for the category _____".

4. The application complete in all respects should be submitted in the prescribed proforma (only in Hindi or English) and should also be duly accompanied with two recent passport size photographs of the nominee.

5. The Central Ministry/ Department/ State Government/ UT Administration may also forward names of eminent

individuals/institutions/employees/employers', who in their opinion have contributed to the empowerment of persons with disabilities, but have not applied for the award themselves.


6. The applications of those employed/associated with the Central/State Governments/Union Territory Administrations/Public Sector Undertakings, should be forwarded through the Ministry/Department/State Government/Union Territory Administration/Public Sector Undertaking concerned. In case of others (including self-employed, those in the private sector organizations/unorganized sector and sportspersons), applications should be routed through and recommended by one of the following:-

- Department of the concerned State Government/Union Territory Administration dealing with disability matters
- Central Ministry/Department dealing with the relevant subject or area
- A National Institute (under the Ministry of Social Justice and Empowerment or Health and Family Welfare) dealing with rehabilitation of Persons with Disabilities.
- Principal Secretary/Secretary, Welfare of the concerned State.
- Collector of the concerned District
- A past recipient of National Award for the Empowerment of Persons with Disabilities

Incomplete applications or applications received after due date and/or not recommended by the competent authorities will not be entertained without any further reference in the matter.

7. Applications/nomination will be initially short-listed and selection of recipients of awards will be made by various Screening Committees and a National Selection Committee respectively. Selected recipients of awards will be reimbursed upto 1st Class or AC-II Tier to and fro train fare from their place of residence for receiving the award in New Delhi. Suitable boarding and lodging arrangements will be made for the recipients of awards, who come from outside Delhi region during their stay in Delhi for receiving the awards.
