Sir,

I am directed to refer to your letters no. AN-I/1341/3/Election-VI, dated 01.02.2016 and to state that in exercise of the power conferred on it by Article 324 of Constitution and Section 20B of the Representation of the People Act, 1951 the Election Commission hereby appoints **10 IDAS Officers** (as per list enclosed) as Expenditure Observer for the General Elections to the Legislative Assemblies of Assam, West Bengal, Tamil Nadu, Kerala and Puducherry, 2016 announced by the Commission vide Press Note no. ECI/PN/16/2016, dated 4th March, 2016 (copy enclosed). The Commission has organized briefing meeting to all appointed Expenditure Observer at Ashoka Hotel, Chanakyapuri, New Delhi on 10.03.2016 as per schedule mentioned below.

2. Under Section 13CC of the Representation of the People Act, 1950 and Section 28A of the Representation of the People Act, 1951, they will be deemed to be on deputation to the Election Commission from now till the completion of election. Working as Observer of the Election Commission they will be under subject to the control, superintendence and discipline of the Election Commission for their duties performed as Observer.

3. As Observer of the Commission, they are entitled for TA/DA as admissible on tour. They will draw TA/DA from their Ministry/Department/Office. The expenditure will be debitable to the Budget grant of their Ministry or Department/Office. They are also entitled to travel by air by any scheduled commercial flight of any Airlines. However whenever they travel by train, it shall be as per their entitled class.

4. The deployment order indicating the State, District and Constituency shall be given during the briefing. They are expected to access the Observer's portal from <http://eci.nic.in> or <http://observerseci.nic.in> and remain in contact with their nodal officer. Their user id and

password for accessing the Observer portal is their Observer Code as mentioned in the list enclosed. They should change their password on first login.

5. In this connection, I am directed to forward herewith a list of Expenditure Observers (10 IDAS Officers) with the request to intimate them immediately with direction to ensure their presence in **Briefing Meeting at Ashoka Hotel, Chanakyapuri, New Delhi on 10.03.2016**. The Expenditure Observers may be informed to report at **11:00 AM** for registration followed by briefing by the Commission as per schedule mentioned below without fail. Failure to attend briefing session may result in disciplinary action.

6. **The Expenditure Observer who shall be deployed in 1st and 2nd Phase of Elections in Assam and West Bengal should come prepared so that they can proceed in the Constituency immediately.**
