



2. Sh. Uma Kant Sharma has requested for consideration of deferment up to 31.03.2016 on the grounds of children education at Delhi as he has already incurred expenditure of Rs.50000/- on admission process. Further, he has added that he was not relieved by IFA(P-75) due to some administrative constraints.

2) The above mentioned officials were considered for posting to Port Blair in the month of August 2013 & September 2013 as per approved panel of Port Blair.

3) HQrs. Transfer policy "Para 3.1" provides that " An individual who has completed his/her prescribed tenure at a hard/tenure station will be asked to give three stations of choice, in order of preference. He/She will be accommodated at his/her first choice station as far as possible as per administrative feasibility."




