

(i) Pass in the Subordinate Accounting Services or equivalent examination conducted by any one of the organised Accounts Departments of the Central Government; **or**

(ii) Successful completion of training in the Cash and Accounts work in the Institute of Secretarial Training and Management or equivalent training course and a minimum of four years experience in Cash, Audit, Accounts and Budget work.

**Note 1.- The Departmental Officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment on promotion.**

**Note 2.- The maximum age limit for appointment on deputation shall be not exceeding fifty-six years as on the closing date of the receipt of the application.**

Note 3.- For the purpose of computing minimum qualifying service for deputation basis, the service rendered on a regular basis by an officer prior to 01<sup>st</sup> January 2006, the date from which the revised pay structure based on the sixth central pay commission recommendations has been extended, shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale, and where this benefit will extend only for the post(s) for which that grade pay or pay scale is the normal replacement grade without any upgradation

Note 4.- Period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organisation or department shall ordinarily not exceed three years which may be extended as per relevant rules or Government orders.
