



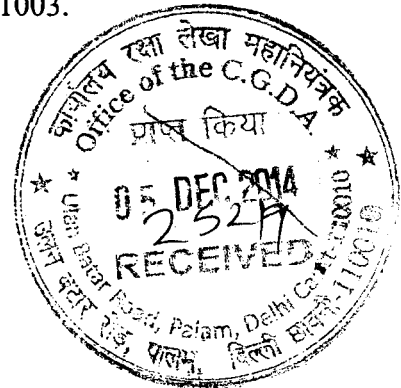

Sub.: Holiday to be observed in Central Government Offices during the year 2015.

The undersigned is directed to refer to your O.M. No. 1/1/2012-D(Civ-II) dated 16th October, 2014 on the subject cited above.

2. In this connection it is stated that Milad-Un-Nabi or Id-E-Milad (Birthday of Prophet Mohammed) falls twice in the year 2015 therefore there will be two closed holidays on account of this festival. It is also clarified that on this account, there is no need to make any reduction in the number of holiday notified for the year 2015. In para 2 of that OM it has been stated that the Central Government Administrative Offices located outside Delhi/New Delhi shall observe the holidays listed therein compulsorily. This inter alia includes the festival of Id-E-Milad (birthday of Prophet Mohammad). It is for this reason that on the account, there is no reduction in the number of holiday notified for the year 2015.
