At the outset, the Chair welcomed the staff side to the 44th Main Meeting.

The minutes of 43rd Main Meeting held on 20.06.2013 were confirmed.

The following Action taken points of 43rd MM were taken up for further discussion:

1. Agenda No. 3/43rd SCM

The proposal regarding promotion of remaining Graduate Clerks.

Further direction : Jt. CGDA(AN) has informed to the staff side that the action to promote the remaining **77** Graduate Clerks who passed the departmental Examination is under examination.

(Action: AN-XI Section)

2. Agenda No. 4/43rd SCM

Issue of Brief case to Non-Gazetted staff drawing grade pay of Rs.4600/-

Further direction: The field offices have already been intimated. The required data is awaited from some Controllers' offices. The Chair directed that as soon as required data is received the same may be sent to Ministry.

3. Agenda No. 14/43rd SCM

Publication of Roster.

Discrepancy reports, if any, in roster displayed in website have been called for.

AIDAEA(HQ) Kolkata has raised the issue that PCA(Fys) Kolkata have not forwarded representations of the individuals regarding discrepancy in Roster.

Further direction: The Chair directed the official side to publish the final Roster of Adrs./AAOs at the earliest. The Chair also directed that in the meantime, the matter may be taken up with PCA(Fys) Kolkata, as to whether any representations are pending with them regarding discrepancy in the Roster.

4. Agenda No. 19/43rd SCM

Reconstitution of ROC during the period of verification of membership.

Action: The issue of reconstitution of ROC during the period of verification of membership has been referred to MoD/D(JCM) and MoD/D(JCM) has intimated that a Writ petition filed by HVT Mazdoor Sangh is pending before the Hon'ble High Court, Madras. The Hon'ble High Court has stayed the reconstitution of all JCM Councils.

It was represented by AIDAA(CB) Pune that the judgment is not applicable to DAD associations.

Further direction: The Chair directed to refer the case to the MoD/D(JCM) for clarification whether the judgment of Hon'ble High Court of Madras is applicable to DAD associations or not. Pending clarification the previous directions given by HQrs. office will hold good.

5. Agenda No. 21/43rd SCM

Promotion of Clerk to the grade of Auditor after 5 years.

The issue of promotion of Clerk to the grade of Auditor after 5 years

Further direction: The Chair informed that the matter has been taken up with DoP&T. The Chair further conveyed that DoP&T is not in agreement with the proposal for promotion of Clerk to the grade of Auditors after 5 years.

The Chair further assured that a proposal for reducing the residency period of qualifying service for promotion of clerks to Auditor from thirteen years to eight years (as a one time measure), will be taken up with Ministry.

6. **Agenda No. 22/43rd SCM**

Recruitment and promotion of Canteen Employees

DoP&T has intimated that the proposal for framing/amendment of RRs shall now be processed only through on-line. Case for issuance of IDs & Pass word have been requested vide HQrs office letter dated 13.08.13, 25.09.13, 19.11.13 & 08.01.14. DoP&T is in the process of issuing user IDs & Pass word after modernization of their system.

It was further confirmed by the Section that the minimum educational qualification for canteen staff have been revised to 10th standard pass from 8th standard pass for entry level of Canteen staff. As such recruitment cannot be made with existing RRs as per DoP&T OM dated 27.06.2011. DoP&T has been reminded to issue the IDs & Password at the earliest.

7. **Agenda No. 24/43rd SCM**

Stepping up of pay in respect of directly recruited Auditors and promotee Auditors.

In order to remove the anomaly of pay between the departmentally promoted auditors and directly recruited auditors on compassionate ground, the data of compassionate appointments made in the department has been disseminated on the CGDA' website to enable the promotee auditors for their stepping up of pay with the directly recruited auditor of compassionate ground.

8. **Agenda No. 1/44th MM**

Comprehensive transfer policy.

All the points, which could not be finalized in the meeting held on 7.11.2013, were discussed and finalized. The Chair directed to submit final transfer policy in light of the discussion.

Other points taken up for discussion:

Point No. 1

Minimum basic pay + grade pay of Rs. 18750/- to all the SO(A), AAO's who were drawing less than Rs. 18750/- on or after 1.01.2006. C&AG has already implemented this to all the AAO's, SO(A) covered up to 31st Aug' 2008.

Both the Associations have insisted to implement the Hon'ble CAT Allahabad judgment dated 9.08.2012 for the benefits to all similarly placed AAOs.

Further direction: The Chair directed the official side to take up the matter afresh with the Ministry to extend of Hon'ble CAT Allahabad judgment to all similarly placed officers, after necessary undertaking from affected officers.

(Action : AN-XIV Section)

Extra Point No. 2 : Model Recruitment Rules

The AIDAA(CB) Pune has raised the issue that the associations were not consulted before finalization of RRs.


Further direction: The Chair directed that in future model RR, as and when received from DoP&T may be circulated for information of all the stake holders.

Extra Point No. 3 : Compassionate appointment

Further direction: AIDAEA(HQ) Kolkata raised the issue of discrepancies in grant of Compassionate appointment by several Controllers. The Chair advised that a circular be issued to all Controllers that compassionate appointment may be made strictly done on laid down procedures.
