**Subject: Promotions from the grade of Senior Accounts Officers to the Junior Time Scale of the Indian Defence Accounts Service on regular basis and transfer of Time Scale officers in IDAS.**

The Government of India, Ministry of Defence has approved promotion of thirteen (13) Senior Accounts Officers, serving in the offices/organizations as indicated against each in **Annexure 'A'** to this letter, to the Junior Time Scale in Pay Level-10 of 7<sup>th</sup> CPC of the India Defence Accounts Service on regular basis. The Competent Authority has decided the postings on promotion in the offices/organizations as indicated against their names in **Annexure 'A'**. On promotion to the Junior Time Scale of IDAS on regular basis, the officer(s) may be designated as ACGDA/ACDA/Dy. IFA, etc., as the case may be. **The promotion of officers shown in Annexure 'A' shall be effective with immediate effect or date of assumption of charge of new post, whichever is later, provided no disciplinary/criminal case is pending against the officers and they are not under suspension (Para 2 and 7 of DoP&T OM No. 22011/4/91-Estt.(A) dated 14.09.1992).**

2. Further, it is also stipulated that in pursuance of DoP&T OM No. 36012/11/2016-Estt.(Res-I) (Pt. II) dated 15.06.2018, the above promotions shall be subject to further orders which may be passed by the Hon'ble Supreme Court on account of interim orders/directions in Special Leave to Appeal (C.) No. 30621/2011 (Jarnail Singh & Ors Vs Lachmi Narain Gupta & Ors.) arising out of final judgement and order dated 15/07/2011 in CWP No. 13218/2009 passed by the Hon'ble High Court of Punjab & Haryana and Special Leave to Appeal (C) No. 31288/2017 arising out of Hon'ble Delhi High Court judgement dated 23/08/2017 and Hon'ble Supreme Court order dated 27/11/2017 in SLP (C) No. 17491/2017 (UOI & Ors v/s Sanjeev Malhotra & Ors) and Hon'ble High Court of Punjab & Haryana at Chandigarh order dated 06/02/2017 in CWP No. 24671 of 2016 (Union of India & Ors v/s Shaneel Rana & Others) and other related court cases.

3. The officers may also be requested that on reporting in the new office of posting, they may inform their date of joining, correspondence address, telephone Nos. (Official, Residential & Mobile) and email id on [an1-pinklist.cgda@nic.in](mailto:an1-pinklist.cgda@nic.in) for updation of the Civil List.

4. The relief of the officer shall not be deferred on the ground that a representation has been submitted for change of place of posting or on the ground that reliever has not reported/been posted. It may be brought to the notice of the officer that no representation for change of posting etc. will be entertained in any case, as the IDAS carries a definite liability to serve any where in India including field service in or out of India. The Pr. Controllers /PIFAs/ Controllers/ IFAs may also ensure that representations are not unduly forwarded.

5. TA and joining time as admissible under rules may be authorized to the officer(s).

6. The date of officers' assumption of charge may please be intimated to this HQrs office by fax/ email. The copies of Part II Office Orders notifying the assumption of charge and fixation of pay in the new grade may be endorsed to this HQrs Office.

7. The above orders may please be implemented on the basis of the order uploaded on the CGDA website. No hard copy of the same will be forwarded.
