विषय : नवम्बर 2019 में आयोजित अधीनस्थ लेखा सेवा परीक्षा भाग-II में उत्तीर्ण वरिष्ठ लेखापरीक्षकों/लेखापरीक्षकों/आशुलिपिक/लिपिक की सहायक लेखा अधिकारी की नियमित रिक्तियों की प्रविजनिंग।

नवम्बर 2019 में आयोजित अधीनस्थ लेखा सेवा परीक्षा भाग-II में उत्तीर्ण वरिष्ठ लेखापरीक्षकों/लेखापरीक्षकों/आशुलिपिकों/लिपिकों (इस पत्र के अनुलग्नक के अनुसार कुल 209 अधिकारी) को सहायक लेखा अधिकारी के ग्रेड में वेतनमान रु. 9300-34800 + ग्रेड वेतन रु. 4800/(पूर्व संशोधित)(सातवें केन्द्रीय वेतन आयोग के स्तर - 8) में तत्काल प्रभाव से या स.ले.अ. के पद पर कार्य ग्रहण करने की तारीख, जो भी बाद में हो, से प्रोन्नति प्रदान करने का निर्णय लिया गया है।

2. उत्तीर्ण कार्मिक(कों) को सहायक लेखा अधिकारी के ग्रेड में पदोन्नत करने से पूर्व यह सुनिश्चित कर लिया जाना चाहिए कि कार्मिक एवं प्रशिक्षण विभाग के दिनांक 14.09.1992 के कार्यालय ज्ञापन संख्या 22011/4/91-Estt(A) के पैरा 2 में उल्लिखित कोई भी परिस्थितियाँ उत्पन्न न हुई हो। यदि ऐसी परिस्थितियाँ उत्पन्न हुई हैं तो प्रोन्नति संबंधी आदेश जारी नहीं किए जाएंगे और यह माना जाएगा कि अधिकारियों की संस्तुति को कार्यालय नियमपुस्तिका के पैरा 7 के अनुसार विभागीय प्रोन्नति समिति द्वारा लिफाफे में सील कर दिया गया है और इस संबंध में मुख्यालय को सूचित किया जाएगा।

3. अधिकारियों को तत्काल प्रभाव से इस निर्देश के साथ कार्यमुक्त कर दिया जाए कि वे स.ले.अ. के ग्रेड में अपनी प्रोन्नति के लिए तैनाती के नए कार्यालय में रिपोर्ट करें। इस संबंध में, यह सूचित किया जाता है कि प्रोन्नति पर अपनी पसंद के स्टेशनों पर प्रतिधारण/तैनाती(retention/posting) के लिए व्यक्तियों से प्राप्त अनुरोधों को ध्यान में रखा गया है और प्रशासनिक रूप से व्यवहार्य सीमा तक समायोजित किया गया है। तैनाती का कार्यालय जो अनुलग्नक में निर्दिष्ट नहीं किए गए हों उन्हें कार्यमुक्त करने वाले कार्यालय के संबंधित र.ले.प्र.नि./र.ले.नि. से तत्काल हासिल किया जाए और अधिकारी को अपनी प्रोन्नति के लिए तत्काल कार्यमुक्त किया जाए।

4. स.ले.अ. के पद पर कार्यभार ग्रहण करने की तारीख से दो वर्षों की अवधि तक परिविक्षाधीन(probation) रहेंगे। तथापि, सहायक लेखा अधिकारी के रूप में प्रोन्नत होने वाले वरिष्ठ लेखापरीक्षकों को कुल दो वर्ष की अवधि के लिए परिविक्षाधीन रखा जाएगा जिसमें वरिष्ठ लेखापरीक्षक ग्रेड में की गई परिविक्षा अवधि को भी शामिल किया जाएगा।
5. किसी कार्मिक को इस आधार पर नहीं रोका जाएगा कि उसके द्वारा दिये गए अभ्यावेदन पर निर्णय नहीं लिया गया अथवा विचाराधीन है। इस संबंध में इस कार्यालय का दिनांक 12.04.1996 का परिपत्र सं. AN/X/10001/2/96/Vol.I का संदर्भ लें।
6. रक्षा लेखा प्रधान नियंत्रकों/रक्षा लेखा नियंत्रकों/एकीकृत वित्तीय सलाहकारों से अनुरोध है कि कार्मिक को संख्याबल से हटाए जाने एवं रिपोर्टिंग की तारीख को अभिलिखित करने के लिए प्रोन्नति आदेश को अधिसूचित करने वाले का.आ. भाग- II की प्रतियाँ मुख्यालय के प्रशासन 9 तथा 11 को अलग से अग्रेषित करें। नियमानुसार ग्राह्य यात्रा भत्ता/दैनिक भत्ता और कार्यग्रहण अवधि प्राधिकृत है।
7. इस स्थानांतरण आदेश में शामिल व्यक्ति(यों) से संबंधित यदि कोई स्थानांतरण आदेश हाल ही में जारी किया गया हो तो कृपया उसे निरस्त माना जाए।

Subject: Provisioning of Senior Auditors/ Auditors/Steno/Clerk who have passed SAS Part-II examination held in November'2019 to the regular vacancies of Assistant Accounts Officer.

It has been decided to promote the Senior Auditors/ Auditors/Steno/Clerk who have passed SAS Part-II examination held in November 2019 as per Annexure {**Total 209 officials**} to this letter, to the grade of Assistant Accounts Officer in the Pay Band - II of Rs.9300-34800 with grade pay 4800/- (Pre-revised) {Level 8, 7th CPC} with immediate effect or from the date of assumption of charge of post of AAO, whichever is later.

2. Before promoting individual(s) to the grade of AAO, it may please be ensured that none of the circumstances enumerated in Para 2 of the DOP&T OM No. 22011/4/91-Estt. (A) dated 14/09/1992 have arisen. If such circumstances have arisen, the promotion shall not be released and instead considered as if, the recommendation of the officials has been placed in Sealed Cover by the Departmental Promotion Committee, in terms of Para 7 of the said OM and an intimation to this effect be given to HQrs.

3. The officials may be relieved of their duties immediately with directions to report to the new office of posting to receive their promotion in the grade of Assistant Accounts Officer. In this connection, it is stated that the requests received from individuals for retention/posting to their choice stations on promotion have been taken into consideration and accommodated to the extent administratively feasible. Office of posting, if any, wherever not specified in the Annexure, may be obtained by the relieving office from the concerned PCsDA/CsDA immediately and relieve the officer thereafter immediately to receive his/her promotion.

4. The AAOs will be on probation for period of two years from the date of assumption of charge. However, Senior Auditors on promotion as AAO should be kept on probation for a total period of two years which included the probation done in Senior Auditor Grade.

5. The relief of the individual may not be held up for want of decision on the representation, if any, submitted by the individual. In this connection, this office circular No. AN/X/10001/2/96/Vol.I dated 12.4.1996 refers.

6. PCsDA/CsDA/IFAs are requested to forward copies of Part. II O.O notifying the promotion order to AN-IX & AN-XI sections of HQrs. separately for recording the date of SOS and reporting. TA/DA and joining time as admissible under rules is authorized.

7. The transfer orders issued recently, if any, in respect of individual(s) figuring in this transfer order may please be treated as cancelled.
