

Promotion to the grade of Principal Controller of Defence Accounts (Higher Administrative Grade) alongwith transfer/posting in HAG of the Indian Defence **Accounts Service.**

Consequent upon the approval of promotion in respect of the SAG level IDAS officers to the grade of Principal Controller of Defence Accounts of the Indian Defence Accounts Service in the level-15 of 7th CPC pay matrix, it has been decided by the Competent Authority to post them in the offices as reflected against their name in Annexure 'A' to this letter. The promotion shall take effect immediately or from the date of assumption of charge, whichever is later. On assumption of charge, the officer may be designated as Principal Controller of Defence Accounts/Principal Integrated Financial Adviser.
