Subject: Promotions from the grade of Senior Accounts Officer to the Junior Time Scale of the Indian Defence Accounts Service on regular basis and transfer of the Officer-reg.


The Government of India, Ministry of Defence has approved promotion of one (1) Senior Accounts Officer, serving in the office/organization as indicated against his name in **Annexure 'A'** to this letter, to the Junior Time Scale of the India Defence Accounts Service in the level-10 of 7th CPC pay matrix on regular basis. The Competent Authority has decided the posting on promotion in the office/organization as indicated against his name in **Annexure 'A'**. Accordingly, the officer may be relieved of his present duties to receive his promotion. On reporting, the officer may be promoted to the Junior Time Scale of IDAS on regular basis and designated as ACDA. **The promotion of officer shown in Annexure 'A' shall be effective with immediate effect or from date of the assumption of charge of the new post, whichever is later, provided no disciplinary/criminal case is pending against the officer and he is not under suspension (Para 2 and 7 of DoP&T OM No. 22011/4/91-Estt.(A) dated 14.09.1992 and Para 8 of DoP&T OM No. 22034/4/2012-Estt. D dated 02.11.2012).**

2. Further, it is also stipulated that in pursuance of DoP&T OM No. 36012/11/2016-Estt.(Res-I) (Pt. II) dated 15.06.2018, the above promotion shall be subject to further orders which may be passed by the Hon'ble Supreme Court on account of interim orders/directions in Special Leave to Appeal (C.) No. 30621/2011 (Jarnail Singh & Ors Vs Lachhmi Narain Gupta & Ors.) arising out of final judgement and order dated 15/07/2011 in CWP No. 13218/2009 passed by the Hon'ble High Court of Punjab & Haryana and Special Leave to Appeal (c) No. 31288/2017 arising out of Hon'ble Delhi High Court judgement dated 23/08/2017 and Hon'ble Supreme Court order dated 27/11/2017 in SLP (C) No. 17491/2017 (UOI & Ors v/s Sanjeev Malhotra & Ors) and Hon'ble High Court of Punjab & Haryana at Chandigarh order dated 06/02/2017 in CWP No. 24671 of 2016 (Union of India & Ors v/s Shaneel Rana & Others) and other related court cases.

3. The officer may also be requested that on reporting in the new office of posting, he may inform his date of joining, correspondence address, telephone Nos. (Official, Residential & Mobile) and email id on **an1-pinklist.cgda@nic.in** for updation of the Civil List.

4. The relief of the officer shall not be deferred on the ground that a representation has been submitted for change of place of posting or on the ground that reliever has not reported/been posted. It may be brought to the notice of the officer that no representation for change of posting etc. will be entertained in any case, as the IDAS carries a definite liability to serve any where in India including field service in or out of India. The Pr. Controller may also ensure that representations are not unduly forwarded.
5. TA and joining time as admissible under rules may be authorized to the officer.
6. The date of officers' assumption of charge may please be intimated to the HQrs office by fax/ email. The copies of Part II Office Orders notifying the assumption of charge and fixation of pay in the new grade may be endorsed to the HQrs Office.
7. The above orders may please be implemented on the basis of the order uploaded on the CGDA website. No hard copy of the same will be forwarded.
