Subject: Promotion and Posting/ Transfer : IDAS officers in Senior Administrative Grade.

In case period of PAR is less than 03 months, 'NRC' may be initiated and completed.

6. TA and joining time as admissible under rules may be authorized to the officer(s) as per the extant rules.

7. The date of relieving/joining / promotion of the officer(s) may please be informed to the HQrs office immediately through fax and copies of Part II Office Order/Office Order issued in this regard may be sent separately to this HQrs office.


