Subject: Promotion of Clerks to the grade of Auditor for the vacancy year 2023.

It may also please be ensured that individual is not promoted till expiry of penalty period, if she is undergoing the period of penalty. The service particulars of the individual furnished in the adjudication report of the DPC may again be verified/checked to ensure the correctness of records before issues of promotion.

3. The case of refusal of promotion may be dealt with by office itself, being the appointing authority in light of provisions contained in DOP&T OM No.22034/3/81-Estt(D) dated 01.10.1981. The HQ's. office may please be informed accordingly.
