**Subject:** Promotion of Accounts Officers to the grade of Sr. AO.

It may also be ensured that any Accounts Officer, undergoing penalty, such as stoppage of increment/reduction of pay on the due date of promotion, is not promoted till the expiry of the penalty period.

The Part-II Office Order in respect of officers serving in IFAs may be published by the respective proforma Controllers. In cases where transfer orders have been issued recently by this Hqrs., new offices have been shown in the Annexure, however, the part II O.O may be notified by the Controller on whose strength the officer is actually serving as on date if not relieved, otherwise by the new Controller in consultation with previous Controller.
