Subject: Promotion of Graduate Clerks to the grade of Auditor on passing Departmental Examination held in September 2010.

45 (**Forty five only**) Graduate Clerks as per Annexure-'A' to this letter, who have been recommended 'FIT" by the DPC held in your office, have been approved for promotion to the grade of Auditor in the pay scale of Rs. 5200-20200 (PB-I) with a grade pay of Rs. 2800/- w.e.f. **01.04.2013** or from the date of assumption of charge of higher post, whichever is later in the same organization where they are serving at present.

2. The promotion may please be notified in the name of PCDA/CDA as appointing authority in the Office Order in the manner prescribed in this office confidential letter No. 0636/AN/D Dated 18/07/1958 and AN/XII/12201/0/3/VOL.III Dated 24/09/1984. Before promoting the individuals, it may be ensured that none of the circumstances enumerated in Para 2 of DOP&T OM NO. 22011/4/91-Estt.(A) dated 14/09/92 have arisen before promotion. If such circumstances have arisen, the promotion shall not be released and instead treated as "Deemed Sealed Cover" case in terms of Para 7 of the said OM. At the time of notification of their promotion it may also be ensured that they are not undergoing penalty i.e., reduction to the lower stage of scale of pay or stoppage of increment etc.

3. If the promotion is not notified for any reason, this fact may be brought to the notice of this HQrs. Office immediately. A certificate in terms of this HQrs. Office No. 0636/AN/XII Dated 17.04.1979 may please be sent in due course.


4. Before promoting the individuals, PCsDA/CsDA are requested to ensure that they have been confirmed in the post of Clerk and such confirmation have duly been notified. Service particulars in respect of the individuals listed in the Annexure may please be checked with reference to (a) adjudication reports (b)

Service Books (c) degree certificate to ensure the correctness thereof before notifying their promotion. A certificate to the effect may invariably be furnished.


