Subject: Promotion of Clerks to the grade of Auditor.

While issuing order of promotion, attention of the individuals may please be drawn to the provisions of Ministry of Personnel, Public Grievances and Pension (DOP&T) OM No. 1/12/97-Estt.(Pay-I) dated 23/4/99 and clarification No. 2 of GOI, Ministry of Finance, Department of Expenditure No. 01/01/2008-IC dated 13.09.2008 regarding exercising of an option by them for fixation of their pay as Auditor.
- 7. Please refer to Hqrs Office letter no.AN/XI/11060/2014/Vol.III dated 10/12/2014 and requested to take necessary action as envisaged therein considering the individual now promoted and DPC may be forwarded so as to reach this office latest by 16/02/2015.
