**Subject:** Promotion of Accounts Officers to the grade of Sr. AO.

2. Before promoting the AOs, it may please be ensured that none of the circumstances enumerated in para 2 of the DOP&T OM No. 22011/4/91-Estt. (A) dated 14.09.1992 have arisen before promotion. If such circumstances have arisen the promotion shall not be released and instead considered as if, the case of the officer concerned has been placed in Sealed Cover by the Departmental Promotion Committee, in terms of para 7 of the ibid OM. It may also be ensured that any Accounts Officer, undergoing penalty, such as stoppage of increment/reduction of pay on the due date of promotion, is not promoted till the expiry of the penalty period.

3. It is stated that the Accounts Officers at Sl. No. 05 and 06 of **Annexure-I** have been approved for promotion to the grade of Sr. Accounts Officer against the vacancies reserved for SC/ST. It is, therefore, requested that their caste verification may please be carried out as per provisions contained in DOP&T O.M No. 36011/3/2005-Estt. (Res), dated 09.09.2005 and a confirmation in this regards may please be intimated to HQrs Office. Further, before notifying the promotion, necessary undertaking as per HQrs Office important circular No. AN/II/2151/PC-1089 (N), dated 11.01.2013 may please be obtained from the officer concerned and a copy thereof may be sent to HQrs Office for records please.

4. The Part-II Office Order notifying the promotion interalia indicating the authority may be endorsed to this HQrs. Office. In cases where transfer orders have been issued recently by this Hqrs., new offices have been shown in the Annexure-I, however, the part II O.O. may be notified by the Controller on whose strength the officer is actually serving as on date if not relieved, otherwise by the new Controller in consultation with previous Controller.
