As you are aware that e-governance has assumed a critical role in the functioning of various Government organizations and local bodies. Properly designed and implemented, e-Governance has the ability to transform relations of various arms of government with citizens and businesses. These technologies can serve a variety of different ends: better delivery of government services to citizens, improved interactions with business and industry, citizen empowerment through access to information. This will usher in an environment with increased transparency, greater convenience, revenue growth, and cost reductions.

2. In view of Government's efforts to have better coordination among its different tiers of Governance, it has been decided that an extensive data base be prepared in respect of all the functionaries in your Ministry/Department including those in attached/subordinate/field offices/PSUs under the administrative control of the Ministry. The data should contain the names, addresses, telephone numbers, e-mail addresses along with any other relevant information. In this regard, deliberations are going on with Department of Information Technology about designing and developing a web-enabled software. The initiative envisages creating services to render social benefits to the citizens of the country which has a widely dispersed population.

3. Till the web-enabled software is designed and developed by the Department of Information Technology, I request you to initiate the efforts to compile the desired data at the earliest. This would ensure time saving in uploading the information once the software is launched. You may please appoint nodal officers in your Ministry / Department to undertake this exercise.

4. Since the initiative is one of the top priorities of the Government, I request for your personal attention to the matter. A meeting under the chairmanship of the Cabinet Secretary on the issue is also likely to be convened shortly. The action taken and the progress made in this regard may please be intimated at the earliest.

I look forward for your cooperation and support.
