Consequent upon declaration of Lok Sabha Elections, it has been decided by the Competent Authority to reschedule the Preliminary Examination (Test) for admission to forthcoming SAS Part I Examination going to be held on 10th April 2014. The examination would now be conducted on 10th June, 2014 as per the following schedule/programme

		PART-'A' Section-I (Common to all)	Candidates are to answer 50 questions each carrying 1 (one) mark.
		PART-'B' (Optional) Section-II – Army Section-III – Air Force Section-IV – Navy Section-V - Factory	Candidates may choose any one from Section-II to V irrespective of the organization in which they are serving. Candidates are to answer 50 questions each carrying 1(one) mark.

2. As per SAS Rule 4, to be eligible for appearing in the Preliminary Test to SAS Part-I examination, a candidate must have put **two years service** as on the first of the month in which examination is held (including continuous temporary service) in any of the grade of Sr. Auditors/ Auditors/Clerks/Typists/DEOs/Stenographers/Hindi Translators and Librarians in the Department provided that candidate must have cleared probation period. Thus, due to rescheduling of examination, the cut of date for counting two years of service will **now be 1st June, 2014**. The other conditions notified vide HQrs Office Most Important Circular dated 20th January, 2014 remains unchanged.

3. The additional list of candidates now eligible due to extension of cutoff date for counting two years of service may be prepared Centre-wise strictly according to the proforma enclosed vide our earlier circular dated 20th January, 2014 and dispatched by name to **Shri Ambarish Barman, Sr.Asst CGDA (Admin) latest by 31.03.2014 (MONDAY) positively.**


