
The Concerned PcDA/CsDA are requested to refer HQrs. letter No. AN/SAS/16102/SAS-II/May-2014/Result dated 09.06.2014 wherein 17 SAS (Apprentices) are declared successful in the departmental examination "Subordinate Accounts Services" Part-II and required to be appointed as Section Officer (Accounts) as per HQrs. office confidential letter No. AN/XI/11051/SAS Apprentice dated 23/12/2002.

2. PCsDA/CsDA being the Appointing Authority may appoint 17 SAS Pat-II passed SAS Apprentices to the grade of SO(A) with effect from the last date of SAS Part-II examination held in May 2014 if not appointed. However, HQrs. has decided to transfer SAS(App) candidates as per Annexure 'B' to this letter.

3. The SAS Part-II Passed SAS apprentices will be kept on probation for a period of two years from the date of their appointment in the grade of SOs(A).

4. In this connection, it is stated that choice stations received from SAS (Apprentices) have been given due consideration but it was not found administratively feasible to post all of them to their choice stations.

5. PCsDA/CsDA/IFAs are requested to forward copies of Part-II O.O notifying the above casualties to AN-IX & AN-XI sections of HQrs. separately. TA and joining time as admissible under rules for local transfer is authorized.




