


The case of Shri Atul Arora, SAO for reversion to DAD on completion of deputation tenure with Aviation Reserch Centre, DG (S), Cabinet Secretariat, East Block-V, R.K. Puram, New Delhi has come to DAPB for consideration. The case has been examined and the following facts have been deliberated upon:

- (a) Shri Atul Arora, SAO has indicated Delhi and Meerut as his choice stations for reversion.
- (b) The officer has been serving in Delhi continuously since August, 1999 except for a short stint in Meerut during the period 01-11-2011 to 21-08-2012 (nine months).
- (c) There are 13 volunteers for Delhi and 2 volunteers for Meerut in the current volunteer list (HYR 04/2015).
- (d) The officer has not cited any compelling grounds for posting to Delhi or Meerut and his home town is Muzaffarnagar, UP.

In view of the above, DAPB recommends that Shri Atul Arora, SAO may be posted to LAO (AF), Bamrauli, Allahabad against existing crucial vacancy.


