

**OFFICE MEMORANDUM**

Sub: Observance of "Sadbhavana Diwas" on 20.8.2013.

The birth anniversary of late Prime Minister of India Shri Rajiv Gandhi on 20<sup>th</sup> August is observed as "Sadbhavana Diwas" nation-wide every year. The theme of Sadbhavana is to promote national integration and communal harmony among people of all religions, languages and regions. The idea behind observance of Sadbhavana Diwas is to eschew violence and to promote goodwill among the people. To promote this idea further, the fortnight beginning from 20<sup>th</sup> August to 3<sup>rd</sup> September is observed as "Communal Harmony Fortnight" every year.

2. An appropriate function may be organized on 20<sup>th</sup> August, 2013, in which all employees of the Ministry/Department/Organizations be associated and "Sadbhavana Pledge" be administered. The text of the Pledge is given on the over-leaf.

3. Further, appropriate events may also be organized during the Communal Harmony Fortnight by the Ministries/Departments including organizations under their administrative control with a view to spreading the message of Sadbhavana and Communal Harmony.

4. It is requested that necessary steps may be initiated immediately and details of the programmes organized in this regard may be intimated to this Ministry.
