

**SUB: FACILITY OF LTC BY AIR DURING WINTER ONLY TO THE GOVERNMENT SERVANTS POSTED IN LADAKH REGION REGARDING**

1. The undersigned is directed to convey the sanction of the President to amend provisions of TR 176 A to the extent indicated below:-

TR 176 A (ii)

**For** - "The facility of air travel will be limited to travel between Leh and Srinagar/Jammu/Chandigarh both for the onward and return journey. This facility would, however, be admissible between Leh and only one of these three places. The journeys between Jammu/Srinagar/Chandigarh and the home town or any other place of visit will be regulated by the normal entitlement of the Government Servant concerned."

**Read** - "The facility of air travel will be limited to travel between Leh and Delhi/Srinagar/Jammu/Chandigarh both for the onward and return journey. This facility would, however, be admissible between Leh and only one of these four places. The journeys between Delhi/Jammu/Srinagar/Chandigarh and the home town or any other place of visit will be regulated by the normal entitlement of the Government Servant concerned."

2. The relevant provisions of the TR would be amended in due course.

3. The above amendment is with the approval of DoP&T conveyed vide their ID No.1079466/2015-Estt.A-IV dated 28 Apr 2015.

4. This issues with concurrence of MoD/(Fin/QA) vide their ID Note No. 16(4)/Fin/QA/2000 dt 16/7/15 (Dy. No. 464).
