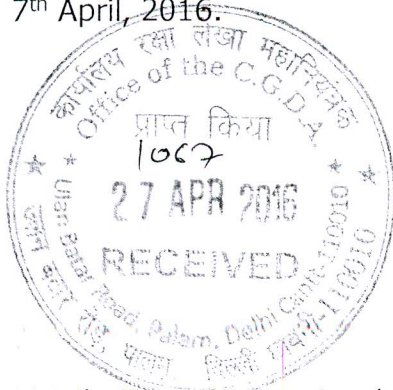
Sir,

I am directed to refer to this Ministry's letter No. 1(2)/2004/ D (Pay/Services) dated 6<sup>th</sup> October 2015, on the subject cited above and to say that the President is pleased to decide that the Dearness Allowance payable to Armed Forces Officers and Personnel Below Officer Rank, including Non-Combatants (Enrolled), shall be enhanced from the existing rate of 119% to 125% with effect from 1<sup>st</sup> January, 2016.

2. The provisions contained in paras 2, 4 and 5 of this Ministry's letter No. 1(2)/2004/D (Pay/Services) dated 25<sup>th</sup> September 2008 shall continue to be applicable while regulating Dearness Allowance under these orders.

3. The additional installment of DA payable under these orders shall be paid in cash to all Armed Forces Officers/ PBORs including NCs(E).

4. This letter issues with the concurrence of Finance Division of this Ministry vide their Dy. No. 132-PA dated 11<sup>th</sup> April, 2016 based on Ministry of Finance (Department of Expenditure) O.M. No. 1/1/2016-E-II (B), dated 7<sup>th</sup> April, 2016.
