**RELAXATION TO TRAVEL BY PRIVATE AIRLINES TO SERVICE
PERSONNEL POSTED IN LADAKH REGION OF J & K TO TRAVEL
FROM LEH WHILE ON LTC**

1. Ministry of Civil Aviation vide letter No. AV-18050/1/2017-AI dated 17 Jul 17 (copy overleaf) has accorded permission to service personnel posted in Ladakh region to travel by Airlines other than Air India while on LTC in Delhi-Leh-Delhi sector as a special case. Since, Air India operates direct service on Delhi-Leh-Delhi sector, its services may, however, be preferred by service personnel to the private Airlines.


OFFICE MEMORANDUM

Subject: Relaxation to travel by private airlines to service personnel posted in Ladakh Region of J&K to travel from Leh while on LTC.

The undersigned is directed to say that relaxation was granted to troops serving in J&K for travel by airlines other than Air India on the Delhi-Leh-Delhi sector on exigencies of work vide this Ministry's U.O. No. AV.18011/05/10- AI dated 01.09.2010. A request has now been received from Director General of Operations Logistics & SM, Integrated HQs of MoD (Army) vide letters No.12647/LTC/J&K/Mov C dated 24th May, 2017 and 21 June, 2017 for relaxation for travelling of service personnel by airlines other than Air India, while travelling on LTC on the Delhi-Leh-Delhi sector as well.

2. The request has been considered in the Ministry and it has been decided to accept the request for travelling of service personnel by airlines other than Air India, while travelling on LTC on the Delhi-Leh-Delhi sector as a special case in view of the extremely harsh conditions of the forward posts and this has been intimated to Addl. Director General, Start Mov, Integrated HQ of MoD (Army) vide Joint Secretary, Ministry of Civil Aviation D.O. letter of even number dated 14.6.2017. This is being issued on a specific request by the Army HQs. for an official GoI letter. Since Air India operates direct service on Delhi-Leh-Delhi sector, its service may, however, be preferred by service personnel over private airlines.
