It has been observed from the e-mpr received from Controllers that there is huge pendency in different types of claims ranging from two months to seven months.

2. Any pendency for more than 30 days is absolutely not acceptable to HQrs office.

3. Separate DO's are being sent to each of PCsDA/CsDA where the situation has not shown improvement since last three four months.

4. The position as compiled from e-mpr is brought as under & the respective PCsDA/CsDA whose pendency position is worrisome may immediately send action proposed to be taken to rectify the situation.
