Subject : Payment of CCG (Crockery, Cutlery & Glassware) Grant to Defence Service officers and Personnel in Mission/posts abroad in lieu of supply of daily use crockery, cutlery and glassware.

Sir,

I am directed to refer to this Ministry's letter No B/25987/AG/PS-3(a)/7058/D(Pay/Services) dated 29 Oct 1987 as amended vide Corrigendum No B/25987/AG/PS-3(a)/1613/D(Pay/services) 21 Mar 1988 and another MoD letter No B/25987/AG/PS-3(a)/146/D(Pay/Services) dated 31.1.1997 and to convey the sanction of President to the revision of rates of Crockery, Cutlery and Glassware grant admissible to Defence Service Officers and personnel posted with Mission/posts abroad as under with effect from 31 Dec 2008 :-

(a) Defence Service officers/personnel - Rs 3400/-

(b) Chauffeurs and Group 'D' Staff - Rs 1100/-

2. All other terms and condition for payment of crockery, cutlery and glassware grant including debiting of expenditure as mentioned in this Ministry's letter dated 29 Oct 1987, mentioned above, remain unchanged.

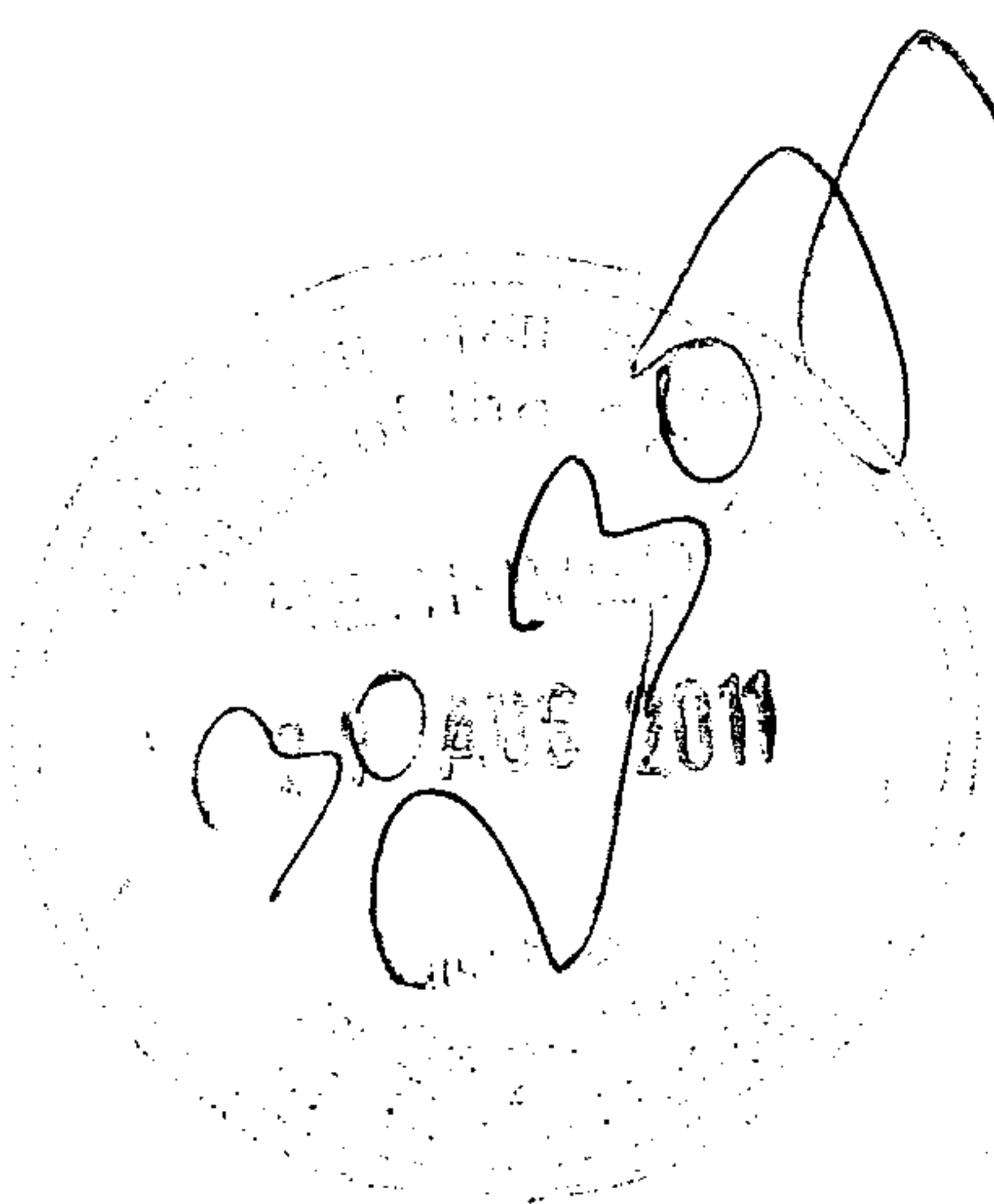

Sir,

In supersession of this Ministry's letter No 4 (2)/88/D(Pay/Services) dated 20 Jul 1988, I am directed to convey the sanction of President to the payment of a lumpsum grant in lieu of Representational use crockery sets to all Armed Forces officers posted to Indian Mission/posts abroad, except the Head of Mission/posts, on the following basis:-

| (ii) Officers of the rank of Counsellors/ Minister or their equivalents in Armed forces | Rs 13000/-
(for a 18 person set) |

2. The grant will be drawn in Indian currency. Officers will become entitled to a grant every time they are posted to a Mission abroad or from one Mission to another. The entitlement will be restricted to a maximum of six times during foreign postings.

3. Officers serving abroad at present will be entitled to the grants provided they have not been provided with representational crockery sets and on the condition that they have not completed half of their normal tenure at the present post on 31 Dec 2008.

4. The existing representational crockery sets will be taken over by the Chancery on the termination of the assignments of the officers who have been allotted them at present.

5. On receiving the grant, officers are expected to submit a certificate to the effect that they have used the grant to acquire representational crockery according to entitlement and of appropriate quality. This certificate should be duly countersigned by the Head of Mission who should satisfy himself personally in this regard.

6. The amount are to be claimed by the officers from the Headquarters/establishment/ship wherever borne prior to posting abroad on a contingent Bill subject to Post-audit.

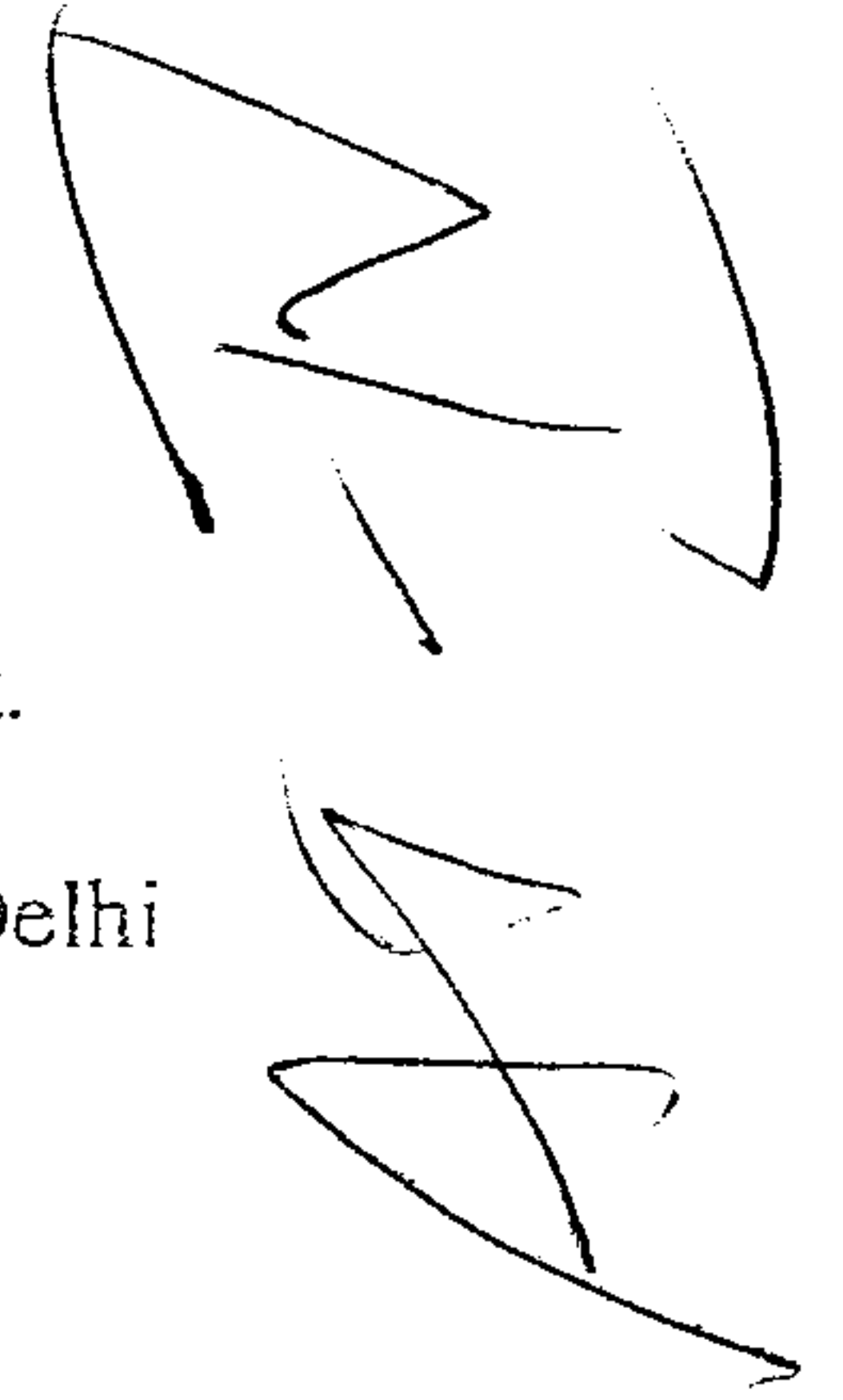

In supersession of this Ministry's letter No. CG/0903/NHQ/2523/D(Pay/Services) dated 15 June 1990, I am directed to convey the sanction of President to the payment of a lumpsum grant in lieu of supply of bed and table linen to the entitled Defence Service officers posted in Missions abroad on following basis:-

Heads of Posts and other entitled officers who are equivalent in rank to officers in Grade III and IV of IFS - Rs 22,000/-

2. The grant will be drawn in Indian currency and the officers will become entitled to grant for each posting abroad from Headquarters to Mission or from Mission to Mission.
3. The entitled officers at present serving abroad and who had requested for bed and table linen prior to issue of the order for lumpsum grant but have not been supplied the same so far, will also be eligible to the grant subject to the condition that they have not completed half of their normal tenure at the present post on the date of issue of these orders. The decision in their cases will be taken after taking into account the date on which they were supplied bed and table linen either in full or in part.
4. The Head of posts and other entitled officers who happen to remain at the same post beyond the period of three years will not be eligible to the grant till they are posted to another Mission.
5. Other terms and conditions as indicated in above mentioned letter dated 15 Jun 1990 of this Ministry.
6. The expenditure will be debitable to the relevant Head of Defence Services Estimates.
