SUB: - GRANT OF TA/DA ADVANCE TO PBOR

Sir,


1. I am directed to refer to the provision contained in TR 17(i) A&B of Travel Regulations, 1991(Edn) under which service pers of Ist Grade are authorised to avail advance on account of Travelling Allowance. Keeping in view the financial difficulty faced by JCOs/PBOR for moving on permanent transfer, the demand PBORs to receive advance of CTG and expenses on transportation of household goods has been considered by the Govt. Accordingly in partial modification of TR 17 (i) A&B of the Travel Regulations, 1991 Edn sanction is conveyed to allow grant of advance of CTG and expenses on transportation of household goods on permanent transfer to PBORs by the concerned PAO.

2. The relevant Rules of Travel Regulations will be amended in due course.

3. These orders will take effect from the date of issue of the letter.

4. This letter issues with the concurrence of Ministry of Defence (Fin/QA) vide their ID No9(3)/98/QA/303 dated 29/05/ 2012.
