

Subject: Risk Allowance to Central Government employees - clarification reg.

Reference is invited to this Department's O.M. No.21012/01/2008-Estt. (Allowance) dated 18<sup>th</sup> June, 2012 wherein the grant of Risk Allowance was extended at the then existing rates beyond 30.06.2012 and upto 31.12.2012. Subsequently, vide this Department's O.M. No.21012/01/2010-Estt. (Allowance) dated October 18, 2012 the rates of Risk Allowance were revised with effect from 1<sup>st</sup> September, 2008, implying that grant of Risk Allowance would be at revised rates w.e.f. 1<sup>st</sup> September, 2008 onwards. Hence, there is no need for issuing separate instructions continuing payment of Risk Allowance beyond 31.12.2012.


