

**Subject: Amendment to the Defence Acquisition Procedure (DAP) 2020.**

Defence Acquisition Council (DAC) in its meeting held on 29.09.2021 has reviewed the provision for ex-post-facto approval of AoN, in respect of the cases where DRDO has commenced D&D prior to accord of AoN. Accordingly, Para-13 of Chapter-IV of the DAP-2020 has been amended as under:


For

Cases for ex-post-facto AoN For on-going cases, where the development had commenced prior to accord of AoN, ex-post-facto approval may be accorded by the DAC.

Read

Cases for ex-post-facto AoN Wherever DRDO has commenced Design and Development prior to accord of AoN, such cases need not be brought to DAC for Ex-Post Facto approvals and concerned AoN according authority may accord the Ex-Post Facto approval as well.

2. The above amendment will be applicable with immediate effect.
