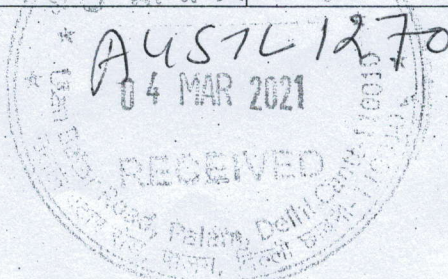
The undersigned is directed to refer to the Cabinet Secretariat's reference no. CCS/03/2021(i) dated 19.02.2021 on the subject mentioned above and to say that Cabinet Committee on Security (CCS) in its meeting held on 17.02.2021 has accorded approval for delegation/enhancement of existing financial powers for sanction of Capital procurement cases under OCP and capital procurement under 'Make-I' as follows:-

(I) Capital procurement under OCP Chapter-X of DAP-2020:

<b>Financial Powers</b>	<b>Competent Financial Authority (CFA)</b>
(a) Upto ₹ 100 Crores:	GOC-in-C, FOC-in-C, AOC-in-C at Command HQ and Regional Commanders, ICG.
(b) Upto ₹ 200 Crores:	DCOAS (CD & S)/ MGS, COM, AOM, DCIDS and ADG ICG.
(c) Upto ₹ 300 Crores:	VCOAS, VCNS, DCAS, CISC and DG ICG.
(d) Above ₹ 300 Crores:	As per delegation of powers defined in Chapter II of DAP-2020.

(II) Capital procurement, under 'Make-I' of Chapter-III of DAP-2020:

<b>Description</b>	<b>CFA</b>	<b>Financial Limit</b>
Project Cost for Prototype Development Phase	CISC/ VCOAS/ VCNS/ DCAS/ DGICG	Upto ₹ 50cr
Project Cost for Prototype Development Phase	Secretary (DP)	₹ 50-250cr
Project Cost for Prototype Development Phase	RM	₹ 250-400cr
Project Cost for Prototype Development Phase	RM & FM	₹ 400-500cr
Project Cost for Prototype Development Phase	CCS	Above ₹ 500cr
