



Subject: Irregularity in creating bid on GeM Portal – reg.

A reference has been received from CEO, GeM drawing attention to a case where a buyer disqualified all bidders except one and the L1 price discovered was unreasonably high. The matter is under examination in Ministry of Defence as to whether the buyer had satisfied himself that the price discovered through the bid was reasonable and due diligence was exercised while creating the bid.

2. All procurement agencies and Integrated Financial Advisers are required to be sensitized so as to scrupulously adhere to the laid down procedure of procurement from GeM so that there is no ground for complaint
3. All Procurement agencies/ lower level CFA/ IFA/ Payment issuing authority may be sensitized so as to avoid such situation in future.
