Please find enclosed herewith GOI MoD (Fin) letter No 15(1)/C/04/ (1646) dated 09 Dec 2004 and CGDA HQRs Office Circular No AN-I/1225/5/TD dated 26.08.2014 on the above subject.

It has accordingly been directed by the competent authority that PIFAs/IFAs will be empowered to undertake temporary duty moves up to 4 days within their respective areas of jurisdiction and the proposal for temporary duty move involving five or more days of PIFAs/IFAs, even within their respective areas of jurisdiction may be forwarded to this HQrs office for obtaining prior sanction of the CGDA. However, it will be incumbent on the officer to ensure that prior intimation of such temporary duty move is communicated to the respective CFAs for their information.

Sub:- Delegation of powers to Integrated Financial Advisers (IFAs) in DAD.

Sir,

I am directed to refer to your U.O. No. AN/VII/7021/IFA dated 29.10.2004 and 30.11.2004 on the above subject and to say that the President is pleased to decide that :-

- (a) the Integrated Financial Advisers in DAD will, under the Delegation of Financial Powers Rules, 1978, exercise all the powers of Heads of Depts. as laid down in Schedules V, VI & VII thereof as amended from time to time.
- (b) the Integrated Financial Advisers in DAD have been declared as Heads of Depts. under the provisions of SR.2 (10) for exercising powers laid down in Fundamental Rules & Supplementary Rules.
- (c) the Integrated Financial Advisers in DAD will exercise the powers of Heads of Depts. under General Financial Rules, 1963 as amended from time to time, except in regard to alteration of date of birth in the case of non-gazetted Govt. servants under note below Rule 79 GFR and;
- (d) The Integrated Financial Advisers in DAD will also exercise powers specifically delegated to Heads of Depts. in various Govt. letters.
