**Sub :- Deficiencies observed in Motor Accident Claims Tribunal Cases (MACT).**

As you may be aware, various authorities are exercising delegated financial powers - 2006, while sanctioning compensation in case of MACT awards. While exercising these powers, some of the authorities are not issuing sanction/allotment letters on the format approved by Ministry of Defence and Army HQrs. Sanction letters also do not contain the UO No. & date under which IFA's concurrence has been obtained, where powers are exercised in consultation with the IFA. Further, sanctions issued under inherent powers, in this regard, by CFAs are also not being endorsed to the concerned auditing and paying controller (PCDA/CDA) for carrying out the audit of sanctions, as prescribed in Rule 68 of FR Pt - I Vol - I.

2. Needless to mention, the ink signed copy of the sanction by the Competent Financial authorities should invariably contain MACT case no., cost of the suit viz. Decretal amount/interim compensation awarded by the court, whom to be paid, amount of interest element along with period involved, code head, the code head of misc expenses including counsel fees to be booked, IFA's UO No. & date (where powers are exercised in consultation with IFAs), allotment of funds by AHQrs etc.



3. In view of above, it is enjoined upon all concerned to advise the executive authorities to ensure that ink signed copy of sanctions issued in compliance of MACT awards are on the proper format and uniform and a copy thereof are invariably provided to the concerned IFA/CDA amongst others duly indicating the IFA's UO No. & date, where ever powers are exercised in consultation with IFA.
